Pursuant to Regulation 31A (10) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations") & SEBI (LODR)Third amendment, Regulations dated December 13, 2024 and in line with the intent expressed by the promoters in the Detailed Public Statement filed under the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, the applications for reclassification of the individuals from the "Promoter/ Promoter Group" category to the "Public" category were received, by the Company, within the prescribed timelines. It is reiterated that after the third amendment dated December 13, 2024, in such cases, Company is not required to comply with Regulations 31A(3) (a) & 31A(8) of SEBI(LODR) Regulations,2015. Further, the Board of Directors of the Company, at its meeting held on March 08, 2025, considered and approved the reclassification of the aforementioned individuals. The outcome of the said Board meeting was submitted to the Stock Exchange on the same day i.e. March 08, 2025.
