बजट : आर्थिक महत्वाकांक्षाएं नरम

केंटार के सर्वेक्षण में दीर्घकालिक आर्थिक महत्वाकांक्षाओं को लेकर आशावाद नरम हुआ है

पिछले साल के बजट से उभरी संतुष्टि की मजबूत भावना के बाद 2026 के केंद्रीय बजट के लिए उपभोक्ताओं का दृष्टिकोण संतुलित यथार्थवाद को दर्शाता है। केंटार द्वारा बुधवार को जारी वार्षिक इंडिया यूनिवर्सल बजट सर्वे के पांचवें संस्करण में यह बात सामने आई है। केंद्रीय बजट रविवार, 1 फरवरी को पेश किया जाएगा।

पिछले साल के बजट से संतुष्टि की भावना मुख्य रूप से कर सुधारों के कारण उपजी थी, जो करों से परे सावधानी को भी दर्शाती है। यह आर्थिक मंदी, आय स्थिरता और भविष्य की तैयारी के बारे में चिंताओं के कारण दिखाई देती है। केंटार द्वारा जारी विज्ञप्ति में कहा गया है कि मुद्रास्फीति संबंधी दबाव, नौकरी सुरक्षा की चिंताएं और वैश्विक अनिश्चितताएं जैसे कारक घरेलू स्तर पर वित्तीय निर्णयों को प्रभावित कर रहे हैं, जिससे खर्च पर संयमित रुख अपनाया जा रहा है और विवेक पर आधारित विकास पर वित्तीय स्थिरता को तरजीह दी जा रही है।

इन्फोसिस के चेयरमैन एवं एकस्ट्रेप फाउंडेशन के सह-संस्थापक नंदन नीलेकणी ने कहा कि दुनिया में आर्टिफिशल इंटेलिजेंस (एआई) के लिए चल रही होड़ के बीच वॉयस एआई भारत में वास्तविक डिजिटल समानता लाने वाला एकमात्र व्यावहारिक जरिया होगा।

नीलेकणी ने एनवीडिया में दक्षिण एशिया के प्रबंध निदेशक विशाल धूपड़ के साथ एक चर्चा में कहा, 'अगर कोई व्यक्ति कंप्यूटर से बात कर सकता है और निदेश या जानकारी वापस पा सकता है या किसी एजेंट को काम करने के लिए कह सकता है तो यह एक ठोस कामयाबी होगी। यह उस देश में और भी अधिक महत्वपूर्ण है जहां कई भाषाएं और बोलियां हैं।'

भारत में 1.4 अरब लोग हैं जिनमें से करोड़ों लोग अभी भी फीचर फोन का उपयोग करते हैं और 100 से अधिक बोलियों में हैं।

नीलेकणी ने आगे कहा कि वॉयस एआई एकमात्र व्यावहारिक इंटरफेस है और भारत में सच्ची डिजिटल समानता की कुंजी है। उन्होंने कहा, 'जिस तरह यूपीआई ने सभी के लिए डिजिटल भुगतान आसान बना दिया है उसी तरह आवाज से चलने वाले इंटरफेस हर नागरिक के लिए कृषि, शिक्षा एवं अन्य जैसे क्षेत्रों में अवसरों की बाधाओं को दूर कर सकते हैं। साक्षरता अब कोई बाधा नहीं रहेगी।'

नीलेकणी ने किरफायती डिजाइन (बनावट) के साथ एक बड़ी आबादी के लिए वॉयस एआई वाले एप्लिकेशन बनाने पर जोर दिया। उन्होंने कहा कि भारत वास्तविक दुनिया की समस्याओं को हल करने के लिए एआई और किरफायती इंजीनियरिंग लागू करने में आगे रहेगा।

उन्होंने कहा, 'इसका वैश्विक स्तर पर उपयोग होगा क्योंकि दुनिया के कई देश इसे वहन नहीं कर सकते हैं। अगर हम 22 भारतीय भाषाओं में बड़ी आबादी के लिए वॉयस एआई तैयार कर सकते हैं तो फिर यह एक वैश्विक जरूरत बन जाएगी। वॉयस एआई अंतिम पड़ाव है। अगर कोई व्यक्ति कंप्यूटर से बात कर सकता है और निदेश या जानकारी वापस पा सकता है तो यही अंतिम निष्कर्ष होगा। यह उस देश में और भी अधिक महत्वपूर्ण है जहां इतनी भाषाएं और बोलियां हैं।'

धूपड़ ने कहा कि वॉयस ऐप का मकसद यह सुनिश्चित करना होगा कि यह निबांध, भरोसेमंद और सरल हो। धूपड़ ने कहा, 'हम सभी जानते हैं कि एक लेन-देन करने पर क्या लागत आती। लेन-देन पर लागत कम करनी होगी। भारतीयों के लिए लागत कम रखने के लिए हमें वॉयस एआई की तरफ कदम आगे बढ़ाना ही होगा।'

रक्षा प्रौद्योगिकी क्षेत्र में 3 गुना बढ़ीं नौकरियां

नई दिल्ली, 28 जनवरी

देश के रक्षा प्रौद्योगिकी क्षेत्र में पिछले तीन वर्षों में भर्तियां लगभग दोगुनी हो चुकी हैं। सीआईईएल एचआर के एक अध्ययन से पता चला है कि विभिन्न पदों पर 2022 में लगभग 3,500 लोगों को रखा गया था, यह संख्या वर्तमान अवधि में बढ़कर लगभग 7,000 हो गई है।

अध्ययन के अनुसार रक्षा क्षेत्र में भर्तियों का रुझान अचानक या अल्पकालिक नहीं है, बल्कि यह सालाना आधार पर लगातार बढ़ रहा है। इससे यह संकेत मिलता है कि इस क्षेत्र में दीर्घकालीन अवधि के लिए आधुनिकीकरण और स्वदेशीकरण से जुड़े कार्यक्रम मजबूती से आगे बढ़ रहे हैं। इसमें यह भी कहा गया है कि लगभग 60 फीसदी कुशल पेशेवरों की मांग रडार सिस्टम, आरएफ इंजीनियरिंग और सुरक्षित संचार प्रौद्योगिकियों से जुड़ी है। यही नहीं, उच्च-तकनीकी रक्षा विशेषज्ञों की भूमिकाओं के लिए महत्वाकांक्षी 2022 के मुकाबले लगभग 30 प्रतिशत बढ़ चुका है। अध्ययन यह भी कहता है कि रक्षा प्रौद्योगिकी क्षेत्र में सबसे ज्यादा एक तिहाई नौकरियां एयर और एरोस्पेस सिस्टम में निकल रही हैं, क्योंकि यह क्षेत्र स्वदेशी लड़ाकू कार्यक्रमों, विमान उन्नयन में तेजी और विनिर्माण तथा एवियोनिक्स यानी विमानों के इलेक्ट्रॉनिक्स सिस्टम में निजी क्षेत्र की बढ़ती भागीदारी के कारण खूब फलफूल रहा है।

पेशेवरों की कुल मांग में साइबर, सी4आईएसआर (कमांड, कंट्रोल, कम्युनिकेशंस, कंप्यूटर्स, इंटीलिजेंस, सर्विलांस एंड रिकोनिसेंस), इलेक्ट्रॉनिक युद्धक सामग्री और अंतरिक्ष प्रौद्योगिकी क्षेत्र की हिस्सेदारी 26 फीसदी है। नौसेना और समुद्री प्रणाली से जुड़े तकनीकी विशेषज्ञों की मांग 19 फीसदी है जबकि लैंड सिस्टम में 14 फीसदी और मानवहस्त प्लेटफॉर्म से संबंधित कार्यों में कुशल पेशेवरों की बर्ती कुल मांग का 10 फीसदी है।
